## SALMON RIVER RUN 2010

What an enjoyable time we had on this run!!!! The river level was 17,500 cfs on Thursday and 16,000 cfs on Friday. The river was clear of debris and there were not a lot of rocks to dodge, but some big rapids to play in. There were a total of 10 boats that showed up for this run. We had a large number of new boaters wanting to learn this stretch of river, which always make me a little nervous when boaters want to use the Salmon River as their first river to learn on.

Jim and Mary came as far as Salem, Oregon and Andy drove down from Spokane, Washington. My cousin also joined us from Baker City, Oregon. Thursday, we ran up and down through the rapids several times and went up river as far as the James Ranch (approximately 60 miles round-trip). On Friday, we ran up as far as Buckskin Bills (approximately 80 miles roundtrip) and back without a single boat mishap, unless you want to count the leader stuffing the nose of his boat through a couple of waves in Ludwig.

## CLUB MEMBERS COMMENTS

### WHAT HAPPENED TO COURTESY?

From one jet boating family to another.

Courtesy is defined as "considerate behavior". You could go a little further and define river courtesy as being considerate of others while on the river. If you are wondering why I feel it necessary to define such basic outdoor common courtesy it's because I see so little of it and I wonder "where have all the courteous men and women gone"?

You may have witnessed inconsiderate behavior by thoughtless teenagers or for that matter you may have been a thoughtless teenager not so long ago, but I'm not talking about teenagers, I'm talking about adult men and women. The type of adults that I thought understood that passing by another boat while tied up in the rocks would want that same boatman to pull the throttle back, pull in close enough to avoid causing the tied up boat occupants to bale out and risk injury to avoid damage to their boat. It does occur, I've seen it, and I've experienced it. Haven't you?

I've experienced that attitude from private and commercial boaters. It has really changed the way I sturgeon fish because I just can't fish many of those holes like I used to because the boats just scream right by. I'm fully aware that there are some locations that passing boats can't slow down due to the heavy current. It would be rude of me to tie-up in those types of locations and expect others to risk damage to their boats.

#### **It doesn't end there, I wish it did.**

What has me so upset is the lack of common courtesies that I see violated almost every time we are on the river. Let me just list a few. I'm sure you can add to the list, please feel free to do so in your own letter because we need to hear from you. Things will not change until we get this out in the open.

1. It's been a long time ago but I can remember it well when camping my mother would say "lower your voice people are camped in the next camp space, you'll disturb them" that is a huge joke now; I can't tell you the last time I could tolerate a campground after 9pm. It's been years.
2. Or how about this... "Don't walk through other 'people's camp" even though it's a short cut to the toilet.

3. Or before leaving the camp space Dad would say... "Police the area!" I mean that meant even the debris out of the fire pit and when we were not in a designated campground it meant "**no trace**" long before the term became trendy
4. While fishing we would never fish next to another boat unless we were a part of the same group. We would never fish in front of someone's shore camp, it just isn't polite. I can't count the times while sleeping on the back deck to enjoy the magnificent stars only to wake up to the sound of fishermen casting plugs to the back of our boat to hook fish that may have found sanctuary beneath it.
5. Playing your stereo on the river or in a campground is just plain rude.
6. When you have a large group in a campground, park the extra cars in the overflow parking. Don't rev-up your 4 wheeler and motorcycles all day and night. Find a large group camping area and observe the universal quiet time rules.
7. While you are sitting around the camp fire passing the bottle telling stories about your misspent youth remember, everyone in all directions can hear every word you are saying. It isn't funny to anybody except the rest of the loud mouth drunks you are with. Contrary to your belief, campgrounds are not a place to "let it all hang out" You can do that in your own home but not where my children are forced to listen at 2am.
8. If you camp on the river remember to separate far enough apart to allow all groups to think they are the only ones there.

They seem to take it for granted, they say "hey it's a beach and that means party"

If people continue to disrespect the River and the River users they will see their privileges taken from them.




