There were 10,000 + post cards sent out boaters across the state regarding the No Wake Zone. It is controversial all over the state not just Valley County. Everyone is responsible for their own wake. The IDPR will be working with the water sports industry county by county looking for ideas and solutions.

## **Old Business**

HCRC information by Shay White: Not much is going on at the present time. Kelly is not getting any reports from the Forest Service. Shay took quite a few pictures of the Pittsburgh Landing campground. It appears to not have been cleaned in quite some time. They are hoping to put together a work session in September. They are hoping to schedule it between the two runs. An example would be the WWA members that can stay a couple of days longer and the IJBA would come in early and hopefully more work can be done. Shay also advised the group that Oregon just passed a law that all non-motorized rafts, boats etc. will all need to be registered.

Bob Hays reported of Salmon Challis Forest plan. By July 31 there should be a full collaborative draft published by the Forest Service. August 8 & 9 the Wild and Scenic task force will be on the Salmon. There will be a field evaluation on the proposed wild and scenic areas. A full plan should be out for comment by August 1. Bob also advised we get our Congressional representatives to get in contact with the Forest Service.

It was brought up that we should make some upgrade the Safety trailer with a new wrap or decals. It will most likely need to be a wrap to cover up the old signage.
